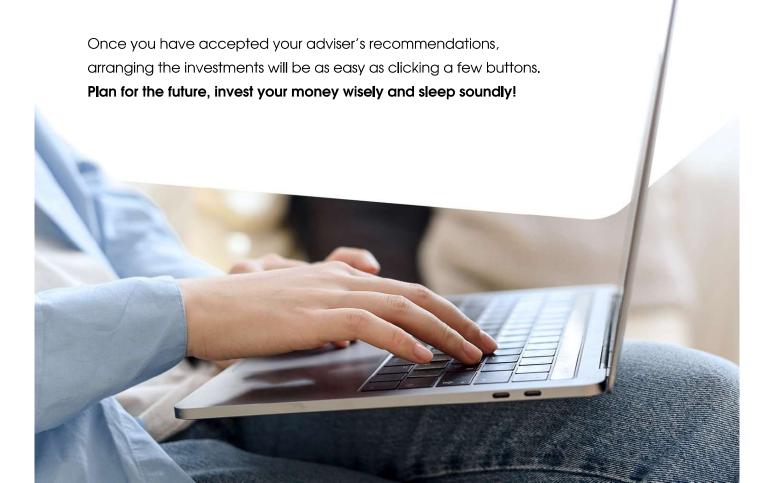
Your adviser will review your personal circumstances with you in an online meeting and make sure all your details are correct
